BUSINESS ITEMS:

A. Transfer Resolutions:

Moved by Director Fery, seconded by Director Strohmeyer, to approve Resolution 2223-04 transferring \$56,500 from General Fund to Apparatus Fund. Motion carried unanimously.

Moved by Director Strohmeyer, seconded by Director Myers, to approve Resolution 2223-05 transferring \$56,500 from General Fund to Building Fund. Motion carried unanimously.

Moved by Director Fery, seconded by Director Myers, to approve Resolution 2223-06 transferring \$51,996 from General Fund to Personnel Fund. Motion carried unanimously.

- **B. Resolution continuing Personnel Fund:** *Moved by Director Fery, seconded by Director Strohmeyer, to approve Resolution 2223-07 continuing the Personnel Fund.* Motion carried unanimously.
- C. Resolution abolishing Rescue Fund: <u>Moved by Director Strohmeyer, seconded by Director Myers, to approve Resolution 2223-08 abolishing the Rescue Fund.</u> Motion carried unanimously.
- **D. Resolution Appropriating Unanticipated Funds:** <u>Moved by Director Myers, seconded by Director Strohmeyer, to approve Resolution 2223-09 appropriating unanticipated funds.</u> Motion carried unanimously.

E. Hiring FF timeline update: Had 21 applications, narrowed down to 16 to interview (last week) and tomorrow Chief will interview 4. Should make a job offer by end of week. We should have 12-14 on a list we can keep for a year.

F. Employee Evaluations:

- a. Rachael Potter: She has completed her 6-month trial period. She is an asset to the district, being very active with recruiter activities, using the reader board, Facebook, etc. Chief recommended she be moved to Step 4 on the pay scale effective March 19, 2023. *Motion by Director Fery, seconded by Director Myers. Motion carried.*
- b. Sean Weitman: Sean has completed 7 years with the district. He is maintaining all his certifications. He is doing a great job and also serving on the Safety Com. There is no change in his pay at this time until his 10-year anniversary.
- **G. Social Media Policy:** Rachael put together this policy so we had better guidelines for personnel to post on Facebook or other social media networks. <u>Moved by Director Strohmeyer, seconded by Director Myers, to approve the Social Media policy as presented.</u> Motion carried.
- **H. OSFM Adapted Home Grant:** We are receiving this grant (\$10,000) for wildfire prevention/education for training, public education, to create our own programs, etc.
- **I.** Accounts Payable: <u>Moved by Director Myers, seconded by Director Strohmeyer, to pay the bills including the additions.</u> Motion carried unanimously.

DIRECTOR'S REPORTS:

• Director Myers asked about helicopter training: scheduled for June 10, part of Recruit Academy and wildland training; will be held in Lyons

CHIEF'S REPORT: nothing to add

ASST CHIEF REPORT: Looking at a VFA grant for wildland shelters and drip torches and at a Homeland Security grant to possibly replace the backup generator at St 80.

GOOD OF THE ORDER:

- Board stated Banquet went well and thanked all who helped put everything together
- Admin asked board if Ok to pay bills online as much as possible after approved at board meeting: ex: on websites, or via bill pay, create a separate list for those being paid online vs checks. Consensus of Board to do this and suggested we create a separate list of those bills paid online.
